

Sonia Amin Thomas



Sonia Amin Thomas, PharmD, BCOP is an Associate Professor of Pharmacy Practice at PCOM-GA School of Pharmacy (PCOM-GA SOP) and a clinical oncology specialist at Northwest Georgia Oncology Center (NGOC) at Wellstar North Fulton Hospital (WNFH) in Georgia.

She attended the University of Georgia for her undergraduate coursework from 2004-2007 and then proceeded to complete her PharmD at South University School of Pharmacy from 2007-2010. Dr. Thomas completed a post-graduate year 1 general pharmacy practice residency in Columbus, GA and received training through post-graduate year 2 oncology residency in Detroit, MI.

At PCOM-GA SOP, she teaches the oncology therapeutics module, clinical reasoning and pharmacogenomics and personalized medicine. At NGOC/WNFH, she precepts pharmacy students and PGY1 residents on an outpatient/inpatient oncology rotation. She works with the oncologist to make cancer treatment recommendations, counsel patients, assist in chemotherapy side effect management and educate the staff and students and also serves as the PGY1 residency program director.

She is also a graduate of the Integrative Institute of Nutrition (IIN) and a health and wellness nutrition coach which aids in preventive and survivorship education for cancer patients.



John M. Tovar



Dr. Tovar recently joined the Philadelphia College of Osteopathic Medicine - Georgia Campus. He serves as Associate Professor and Chair for the Department of Pharmacy Practice. Prior to this, Dr. Tovar spent 6 years abroad where he served as CEO and Academic Director for RICERCA Medical and Clinical Services in the city of Arequipa, Peru. Dr. Tovar also served as an Associate Professor in the department of Pharmacy Practice at the University of the Incarnate Word Feik School of Pharmacy and as a Clinical Assistant Professor in the department of Family and Community Medicine at the University of Texas Health Science Center at San Antonio in San Antonio, Texas. He graduated from the University of Florida with a Doctor of Pharmacy degree in 2002 and then completed a 2-year fellowship in Family Medicine at the same institution. He is a registered pharmacist in Texas.

Dr. Tovar has been published in numerous medical journals including the Annals of Pharmacotherapy, Journal of Pharmacy Practice, Postgraduate Medicine and Journal of Family Practice. He has also co-authored chapters on infectious disease topics in 2 medical/pharmacy handbooks; Internal Medicine at Your Fingertips and Pharmacotherapy Point of Care Guide. Dr. Tovar has presented at numerous national and international meetings. Dr. Tovar's areas of research interest include cardiovascular and infectious diseases. More recently, Dr. Tovar has begun researching teaching methodologies used in the education of pharmacists. He is also a passionate advocate for immunizations.

Dr. Jennifer M. Trujillo, PharmD, BCPS, CDCES, BC-ADM, FCCP, is a Professor in the Department of Clinical Pharmacy at the University of Colorado Skaggs School of Pharmacy and Pharmaceutical Sciences in Aurora, Colorado. She received her Doctor of Pharmacy (PharmD) at the University of Arizona and completed her pharmacy practice residency at Boston Medical Center.

She is a fellow of the American College of Clinical Pharmacy. She teaches a variety of topics in the Doctor of Pharmacy program including diabetes pharmacotherapy and advanced diabetes management. She serves as a preceptor for APPE students and PGY1 and PGY2 residents. She is a clinical pharmacist at The University of Colorado Diabetes and Endocrinology Clinic. She is a board-certified pharmacotherapy specialist, an advanced diabetes manager and a certified diabetes care and education specialist.

She has published over 50 peer-reviewed manuscripts and has been involved in clinical research as well as the scholarship of teaching and learning since 1999. She has multiple publications and presentations related to diabetes management, curricular innovation, instructional design, teaching and learning and assessment. She is an associate editor of the journal *Diabetes Spectrum* and is part of the editorial board of *Pharmacotherapy*.

She has been an active member of multiple organizations including AACP, ACCP, APhA, Rho Chi and the American Diabetes Association. She has served on several national committees and has presented numerous oral sessions and posters. Most recently she served as Chair of the AACP Council of Faculties



Toby C. Trujillo



Dr. Toby Trujillo, PharmD, FCCP, FAHA, BCPS-AQ Cardiology, is an Associate Professor of Clinical Pharmacy at the University of Colorado Skaggs School of Pharmacy and Pharmaceutical Sciences in Aurora, Colorado. He also serves as Clinical Specialist in cardiovascular pharmacotherapy and anticoagulation at University of Colorado Hospital. Dr. Trujillo earned his Bachelor of Science degree in biochemistry from the University of California, Davis and his Doctor of Pharmacy degree from the University of California, San Francisco, where he also completed a residency in pharmacy practice.

Dr. Trujillo completed a fellowship in cardiovascular pharmacotherapy at The University of Arizona, and he is a board-certified pharmacotherapy specialist with added qualifications in cardiology. In his current role, Dr. Trujillo is involved in the stewardship of antithrombotic medications across the UC Health System, which includes serving as co-chair of the anticoagulation subcommittee of the P&T committee, as well as coordinating and staffing the Inpatient-Anticoagulation Thrombosis Management Service.

Dr. Trujillo has served in several capacities within multidisciplinary organizations such as the American Heart Association, American College of Cardiology, and the Society of Critical Care Medicine. Dr. Trujillo has also served a number of committees and leadership positions within the American College of Clinical Pharmacy including currently serving on the Board of Regents. Dr. Trujillo has served as a speaker on numerous occasions on a national and international level, and has published over 70 original research articles, review articles, and book chapters dealing with the area of cardiovascular pharmacotherapy. His research interests primarily focus on the appropriate use of antithrombotic medications, both at the patient and health-system level.
